## Special Guest Heather Flowers, Magnolia House/Waycross Family Justice Center

The Waycross Family Justice Center will be a multi-agency one stop center for victims of domestic violence, sexual assault, child abuse, and elder abuse giving them one time to have to tell their story. There will be on-site partners and off-site partners including but not limited to law enforcement, Unison Behavioral Health, Department of Children and Family Services and Cord of Three. There will be a multi-purpose room for trainings and meetings. The building will be set up like a home to make it feel safe and comfortable. 2.88 acres of land has been purchased and Magnolia House has received \$1 Million towards the building. They are starting back with the work groups.

Memorandums of Understanding (MOU) have been being signed with organizations to assist with needed trainings and events. Brantley County High School Sources of Strength just partnered and Resilient Georgia provided Snow Biz for the youth.
